

INTRODUCTION

- (U) The U.S. Navy prepared this Annual Range Complex Exercise Report covering the period from 02 January 2011 to 01 January 2012 pursuant to the National Marine Fisheries Service (NMFS) Marine Mammal Protection Act (MMPA) regulations for the Virginia Capes (VACAPES) (50 C.F.R. Part 218, Subpart A), Jacksonville/Charleston (JAX) (50 C.F.R. Part 218, Subpart B), Navy Cherry Point (CHPT) (50 C.F.R. Part 218, Subpart C), and Gulf of Mexico (GOMEX) (50 C.F.R. Part 218, Subpart D) Range Complexes. The report also provides the information required by the terms and conditions found in the 17 March 2011 and 6 January 2012 biological opinions (BOs) and incidental take statements for training activities occurring in the GOMEX and East Coast (VACAPES, CHPT, JAX) Range Complexes (NMFS 2011, 2012). The scope of activities covered in the NMFS BOs include the same training activities using explosives covered by the above MMPA regulations, and also include non-explosive training conducted in the VACAPES, JAX, CHPT, and GOMEX Operating Areas (OPAREAs), Navy training in the Northeast OPAREAs, and activities associated with the Transit Protection System at Naval Submarine Base Kings Bay, Georgia. Figure 1 illustrates the geographic extent of the VACAPES, JAX, and CHPT OPAREAS, figure 2 illustrates the Northeast OPAREAS, and Figure 3 illustrates the GOMEX OPAREA.
- (U) In the MMPA regulations¹ and associated Letters of Authorization (LOA) for the VACAPES, JAX, CHPT, and GOMEX Range Complexes (NMFS 2012a-c, NMFS 2011a) the following reporting requirements were specified and are presented in Sections I-IV of this report:
 - (1) Total annual number of each type of explosive exercise (of those identified as part of the "specified activity" in the regulations) conducted in the VACAPES, JAX, CHPT, and GOMEX Range Complexes.
 - (2) Total annual expended/detonated rounds (missiles, bombs, etc.) for each explosive type.
- (U) In NMFS' 2012 East Coast (NMFS 2012) and 2011 GOMEX (NMFS 2011) BOs the above exercise reporting requirement is repeated as a term and condition that implements, in part, the Reasonable and Prudent Measure listed in the Incidental Take Statement. The measure is the same as the exercise reporting requirement from the above MMPA regulations and is also addressed in Sections I-IV of this report.
- (U) In addition, each of the range complex MMPA LOAs and regulations require an update from Navy on the status of its explosive training tracking efforts. While Navy units, such as ships and aircraft, report a variety of information on a routine basis, a specific process for reporting and tracking the required information did not exist when the MMPA authorizations were finalized. The following update describes refinements to the Navy's tracking process since the previous reporting period.



- (U) As reported in Navy's 2009 report, a protocol has been established to monitor and track the number of events conducted and the type and amount of ordnance used for those activities identified in the MMPA authorizations. To summarize, data collection efforts are a result of a collective team effort between the Fleet Forces Range Complex Support Team (RCST) personnel and Fleet users. RCST personnel receive the weekly operating schedules promulgated by the Range Scheduling Offices. Through this scheduling process and daily coordination with the Scheduling Agencies and Fleet users, RCST personnel are aware of what activities are being requested in the operating areas and receive after-action reporting of high explosive (HE) munitions expenditures. The after-action reporting is accomplished by direct interface with the naval unit upon completion of the event and reviewing the naval unit's Ammunition Transaction Reporting message that reports the type and amount of ordnance expended. The collected data is then entered into a database for analysis and reporting.
- (U) In 2011 changes were made to the VACAPES and JAX MMPA regulations via an interim final rule (76 Fed. Reg. 30552) that allowed for changes in the explosive types or activities listed in the original authorization. This change resulted in the 2011 and 2012 LOAs increasing the frequency of some events (e.g., mine warfare training in VACAPES) and decreasing the frequency or type of ordnance in other events. While these changes were authorized in the interim final rule and associated LOAs, the rule does not allow the overall 5-year marine mammal take authorization to be exceeded.
- (U) To ensure the 5-year take authorization is not exceeded, the Navy now routinely tracks the estimated exposures that resulted from explosive events conducted. Exposures are quantitatively calculated based on outputs derived from the Navy's original modeling and the cumulative estimated exposures are provided in new tables within Sections I-IV for each range complex.
- (U) The information contained in this report represents the best practical data collection as of 01 January 2012. The report provides an accounting of a full year of training from 2 January 2011 to 1 January 2012. The report also includes the cumulative amount of events and ordnance expended since the start of the authorizations for the East Coast (5 June 2009 1 January 2012) and GOMEX (18 March 2011 1 January 2012). The data provided in the following tables indicates that as of 1 January 2012 the Navy is not exceeding the 5-year estimate of training events or takes specified in the MMPA authorizations and ESA incidental take statements. However, it should be noted that Navy training events are variable within any given year based on the availability of strike groups undergoing training certification, logistics and fiscal considerations as they impact scheduling, and real-world commitments to other regional locations (North Atlantic and Mediterranean deployments, counter-piracy operations, disaster relief, etc.). Therefore, the data on the amount of annual training may vary on an annual basis, possibly resulting in higher or lower amounts of reported training events in future annual exercise reports.




VACAPES, Jacksonville, Cherry Point Study Area
